2. PARA's Contract Ratified – the Personnel Committee met before today's meeting to discuss the PARA's Contract needing to be ratified. The changes that needed ratifications are Wages and Insurance. We discussed how our PARA's were being underpaid and also they were paying 50% of their benefits for their families. The need for ratification is to help with recruiting, retention, and attracting prospective employees. (see attachment for a detailed explanation).

VII. LEGISLATIVE UPDATE

Patrice reported that the upcoming legislative session begins in February and will end in May. Legislators are optimistic that public access to the Capitol and LOB will resume for the 2022 session. Task forces have been meeting, although some are moving rather slowly. CABE will hold the annual Delegate Assembly on November 11. The CREC Council will be well represented, with CABE President Don Harris presiding and Meg Scata serving as Resolutions Chairman.

Deb Borrero reminded council members of the upcoming Legislative Committee meeting on 11/10 and also the Legislative Breakfast on 2/24/2022.

VIII. REPORTS

Sandy Cruz-Serrano presented the financial summary as there are no changes to the budget. She reported we still have auditors in our operations building. The RSCO audit will be conducted in the next two weeks and will report the findings in our January meeting.
