Public Safety Academy: 2015 – 2016 Capital Projects Fund Construction Division

The CREC Public Safety Academy construction project has an approved construction grant of \$69,403,883. The school is situated on 27 acres at 1617 King Street, Enfield, Connecticut. The 145,000 square foot facility opened in August 2014 and was designed to accommodate 700 students, grades 6-12.

The architect, The S/L/A/M Collaborative, has completed the revised final plans and the professional cost estimate for Phase 3. This phase was originally approved by the CREC Council on November 20, 2013. This revision requests expenditure of \$100,000 for certain scientific academic equipment that was not included in the original approved plans.

The project is being reviewed in phases according to the Office of School Construction Grants' ("SCG") guidelines, as follows:

- Phase 1 of 5 Site Work
- Phase 2 of 5 Construction
- Phase 3 of 5 Furniture, Fixtures and Equipment
- Phase 4 of 5 Technology Equipment
- Phase 5 of 5 Photovoltaic Array and Security Upgrades

In addition to these five phases, the project also has "soft costs", which include architectural design services, other professional services, site acquisition and contingency.

SCG must now complete a plan review in order for CREC to bid the revised Phase 3. As part of the process, SCG requires the Council's approval of the final plans and professional cost estimate for Phase 3.

<u>RECOMMENDED ACTION</u>: Approve the submission to SCG for Phase 3 – Furniture, Fixtures and Equipment (final plans and the professional cost estimate) for the CREC Public Safety Academy project.
