I. CALL TO ORDER and APPROVAL of MINUTES

III. PRESENTATIONS to COUNCIL

Magnet School Presentation by Sasha Douglas, Elaina Brachman and Dana Turnquest. The focus of the presentation was on restorative practices and how that impacts not only students but also staff. They discussed the meaning of restorative practices as well as the benefits of having such programs in schools and programs. CREC schools and programs have what we call Circles where students (and sometimes staff) come together to discuss any issues going on or just to talk about their day, feelings, and emotions. Students, known as Circle Keepers, joined us from two CREC schools, namely Arts Academy High School and Impact Academy. The students talked about their roles, why they chose to become Circle Keepers, the positive impact of restorative practices and how they implement those skills into their everyday lives.

Meg Scata gave the finance and audit committee report with respect to the meeting that was held on February 12, 2025. The Annual Comprehensive Financial Report was discussed for fiscal year 2024. The audit came through without any issues. Additional money for new programs including employee benefits and new hire processes was added.

IX. LEGISLATIVE UPDATE

Patrice McCarthy reported on a press conference scheduled for that morning at 10:30 called by the leadership of the House and Senate. There will be a special session next week to appropriate an additional \$40M for the current year, Special Education excess cost grant. Although that is only half of what was requested, it is still a huge step in the right direction. The Appropriations Committee will meet tomorrow to hear the education portion of the budget. The ultimate issue, per usual, is getting the State to approve more money for magnet schools and helping individual districts cover the rising cost of magnet schools.
